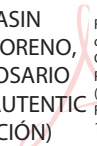
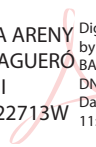
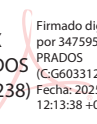


Procedure for the Foreign Degree Recognition by the Ministry of Education and Training

1. Introduction and scope

The recognition of a foreign degree is the procedure through which the Spanish Ministry of Education and Training and Sports acknowledges a degree obtained abroad as equivalent to an official Spanish degree. This process is essential for working in certain professional fields or for accessing higher education levels in Spain.

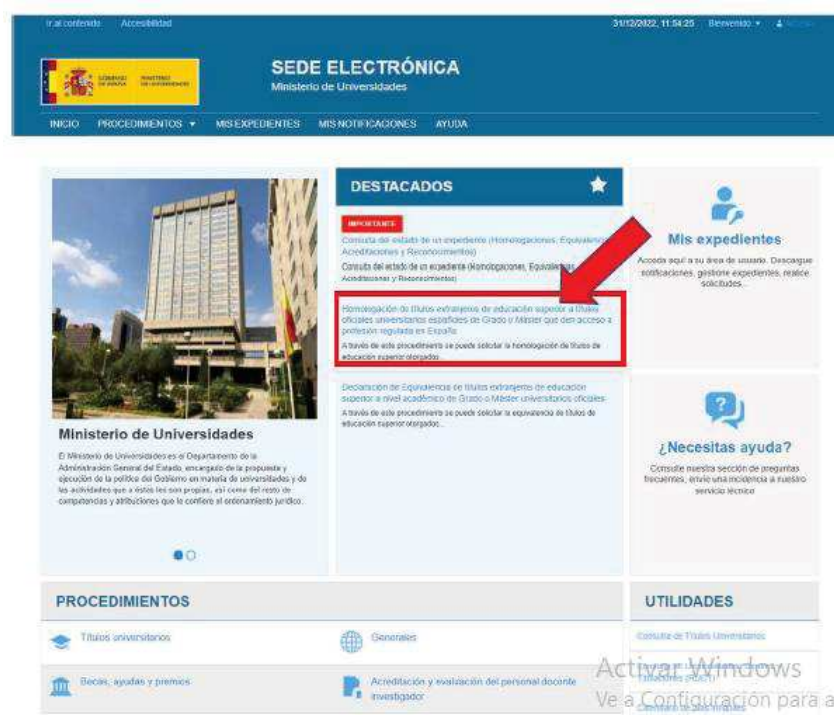
The recognition of foreign higher education degrees as equivalent to official Spanish bachelor's or master's degrees that grant access to a regulated profession in Spain is a continuously open process.

2. Instructions

- **Verify the requirements and degree compatibility:**

Before starting the process, make sure that the degree obtained abroad is eligible for recognition in Spain. The requirements may vary depending on the type of degree (undergraduate, masters, etc.) and the country of origin.

Check the updated conditions and regulations on the [online portal](#) of the *Ministry of University* website.



- Prepare the required documentation:
 - [Application Form](#)
 - **Original foreign degree:** It must be official and accompanied by an official Spanish translation, if necessary.
 - **Academic transcript:** Including the courses taken and the grades obtained, also translated into Spanish.
 - **Study programme (if applicable):** A detailed description of the curriculum followed during the studies.

- o Additional documentation: Proof of teaching or professional experience related to the degree, if required by the Ministry.
- Submit the application

Since the entry into force on 8 November 2022 of the Royal Decree of 18 October regulating the recognition, equivalence, and validation of foreign university degrees, as well as their correspondence with the Spanish Qualifications Framework for Higher Education (BOE 19/10/2022), all recognition applications must be submitted exclusively through the Ministerio de Universidades' online portal: <https://universidades.sede.gob.es>.



- Payment of fees

The recognition procedure involves a fee, which must be paid through the methods established by the Ministry ([Modelo 790-107](#))

- Application Tracking

Once the application has been submitted and the fees paid, you will receive a registration number to [track the status of your application](#).

- Application Resolution

The Ministry will review the application and the submitted documentation to determine whether the degree is eligible for recognition.

If the degree meets the necessary requirements, the application will be approved, and the degree will be officially recognized as equivalent to a Spanish degree. If additional information is needed or discrepancies are found, the Ministry will contact the applicant.

- **Collection of the recognized degree**

Once the degree has been recognized, you will be able to collect the official recognition certificate from the Ministry.
